### **Governor Updates**

## **Attendance**

Attendance is a big focus for Barnet and our schools this year. If your child is not in school, they cannot learn. Please ensure that your child attends school every day, and restrict appointments where possible to out of school hours. If you have any concerns about your child or would like advice on attendance please speak to the school offices.

#### **School Budgets**

The Governors have approved the 2016-17 budgets for both schools. Thanks to both Headteachers, the Finance committee and especially Vice Chair Katie Atwood for all their hard work on this huge undertaking. As you may already know, the London Borough of Barnet no longer gives Brookland Schools funding for the upkeep of our swimming pool. We are very lucky to have a swimming pool on site – it is part of the National Curriculum and many other schools have to travel, at considerable expense, to allow their students to fulfill this criterion. Unless we make up for this shortfall in parent contributions we cannot guarantee the future of the pool. As swimming starts again after the holiday break, please contact the school offices if you are unsure if you have made your voluntary contribution towards this valuable resource.

# **School Development Plans/Self-Evaluation Forms**

Both schools have produced these key documents, which have been reviewed and validated by the governors. These documents take an incredible amount of work from all the staff, are vital to the schools' review of their targets, achievements and

future plans, and are essential documents in preparation for any future Ofsted review. We thank all the staff for their input.

#### **Curriculum Tea**

In January the governors hosted the annual joint Infant and Junior school curriculum tea. Subject leaders, governors and other staff members of both schools were given the opportunity to discuss and share details of the ongoing curriculum development. All staff are working very hard to integrate the changes to the National Curriculum into our wonderful "Creative Curriculum". # **School Improvements**

Both schools are continually working to improve our schools and the school site. The Infant School is currently raising money for new toilets for the children and the Junior School has just installed path lights to the top playground gate across the field with a successful funding application resulting from their Gold Travel Plan Award.

Recently the Junior School had a Safeguarding Audit carried out by an external expert. She conducted a thorough evaluation of the procedures and spoke to several governors as well. The conclusion was that Brookland Junior School takes safeguarding very seriously, has a strong safeguarding culture and has all policies and procedures in place to make the school as safe as it could possibly be for everyone.
